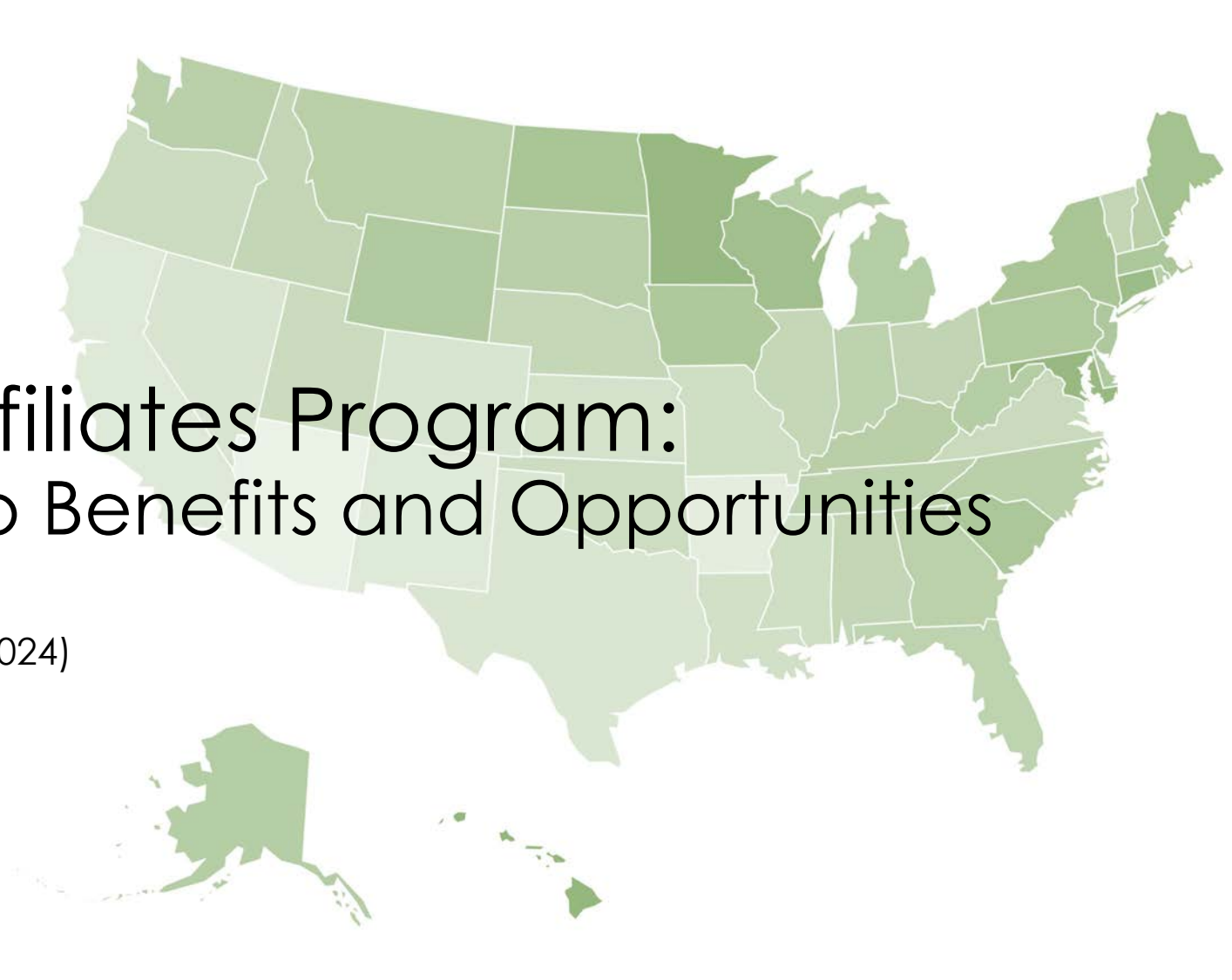

 - Committee meetings typically occur quarterly (either virtually or in-person as part of NASEO conferences) to engage members on specific issues and educational opportunities
- Task Forces, Working Groups, and Advisory Groups
 - Cover specific topic areas to inform NASEO projects, publications, and policy and program messaging
 - Member participants in these groups are more defined than in Committees, but typically time-bound and ad hoc

NASEO Hosts King, Tonko, Podesta, Turk, Clements, and More at 2023 Energy Policy Outlook Conference

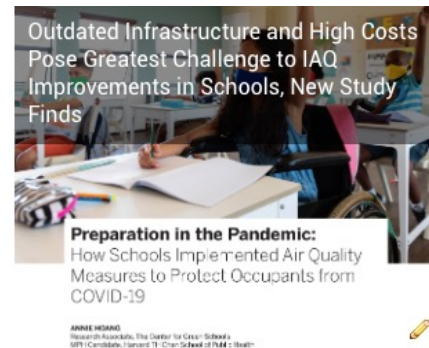
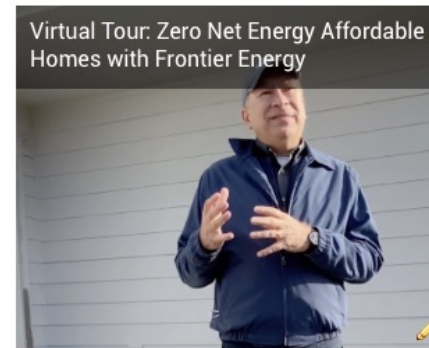
The [NASEO 2023 Energy Policy Outlook Conference](#) brought together State and Territory Energy Office leaders from across the country to discuss the evolving landscape of clean energy, climate, and economic development policies at the state and federal level. In addition to presentations, updates, and exchanges among the states, the conference featured remarks from a wide array of Congressional, federal, and private sector leaders and experts, including Senator Angus King, Congressman Paul Tonko, Deputy Secretary for Energy David Turk, Senior Advisor to President Biden for Clean Energy Innovation and Implementation John Podesta, Federal Energy Regulatory Commissioner Allison Clements, and Form Energy Co-Founder Ted Wiley.



The conference reflected the critical importance of State and Territory Energy Offices in informing and implementing the investments needed for a decarbonized, affordable, reliable, and resilient economy. From large-scale transmission, distribution planning, electrification, and grid resilience investments to the billions of dollars overseen by states for home energy improvement rebates, clean energy project financing, electric vehicle infrastructure expansion, small-scale renewables, and building energy codes, the State and Territory Energy Offices are engaging and planning with partners in their communities as well as regionally and nationally.
